The 2023 Conference will be held in Tulsa, Oklahoma – nestled between the lush Ozark hills and miles of wild prairie, this former oil boom town now anchors a bustling metropolis of 1 million residents who enjoy one of the Top 10 live music scenes in the country and one of the nation's most up-and-coming arts districts. From Woody Guthrie's and Bob Dylan's museums to the realities of the horrific race massacre on Black Wall Street in May 1921 and the nation's number one city park, The Gathering Place, all offer a glimpse of Tulsa's history and background. Along historic Route 66, Tulsa is centrally located for easy access from all parts of the county with an uncrowded and easy-to-navigate airport.

Comprised of two large metropolitan cities and 75 counties, Oklahoma sadly led the nation in female incarcerations for 30 years (1991 to 2019). Much has been learned and changed during this time thanks to criminal reform advocates who have worked closely with correctional institutions, treatment providers, policy makers, funders, criminal legal practitioners, and academicians, all eager to share lessons learned. Tulsa's diverse cultural resources combined with the insight and experience of warm and welcoming community stakeholders will provide a rewarding and informative experience for AJFO's 2023 national convening.
